In NYC we call the first group eager beavers. DSNY designs their outreach mainly for them. The next group needs convenience, 3rd needs peer support, 4th needs incentives, 5th group needs disincentives.

We're working in a community in MA rolling out a citywide weekly food waste composting program to 20,000 hhlds at no cost to residents. The City didn't want to adopt a mandatory ordinance, but have contracted to move to an every-other week (EOW) trash service within 3 years. A key message to get residents to sign up for food composting will be to get organics out of the trash so EOW trash collection will work for them. Do you know of other communities that are leveraging the phase-in of EOW trash to motivate the "Early Majority" to sign-up for food waste composting?

A couple of DEI factors to consider in siting facilities:

- Residential population within 2.5 miles of the center point of the landfill is no greater than 2,500 in the 2020 U.S. Census.
- Non-Hispanic White population within 2.5 miles of the center point of the landfill is no less than 70% in the 2020 U.S. Census.

Perhaps a way to overcome embedded political opposition would be to run "teach-ins" on how to write and pass citizen's initiatives. Every one I've been involved in writing was a series of "whereases" ending in "therefores." The important thing is that all the whereases have to be true, and the therefores come naturally as the end product of all thinking based on the whereases. One of ours stopped an incinerator; another created a funding agency now called StopWaste funded by landfill surcharges.
